

**TOWN OF SCOTT, BOWN COUNTY, WISCONSIN  
MINUTES OF 2009 BOARD OF REVIEW - MAY 12 2009, 4:00 P.M.**

**1. Call To Order**

The 2009 Town of Scott, Brown County, Wisconsin 2009 Board of Review was called to order at 4:00 P.M. on Tuesday May 12, 2009 in the Town Hall. Present were Chairman Mike Van Lanen, Supervisor Cyril Van Laanen, Supervisor Kenneth Jacobs, Supervisor Tom DePas, Supervisor Jeffrey Zlatohlavek, Clerk/Treasurer John Roth, and Assessor Robert Taicher.

**2. Appointment of Chairman of 2009 Board of Review**

**MOTION KEN JACOBS/CY VAN LAANEN** to nominate Mike Van Lanen as Chairman of the 2009 Board of Review. There were no other nominations. Vote: Aye-5, No-0. Carried.

**3. Appointment of Vice-Chairman of 2009 Board of Review**

**MOTION TOM DEPAS/JEFF ZLATOHLAVEK** to nominate Ken Jacobs as Vice-Chairman of the 2009 Board of Review. There were no other nominations. Vote: Aye-5, No-0. Carried.

**4. Approval of Affidavit of Posting**

Clerk Roth presented an affidavit that stated that the notice of the 2009 Board of Review had been published in the Green Bay Press Gazette on April 28, 2009 and posted on five bulletin boards in the Town of Scott on April 27, 2009.

**MOTION TOM DEPAS/KEN JACOBS** to approve and file the affidavit of posting. Vote Aye-5, No-0. Carried.

**5. Certification of Board Members Training.**

Roth presented a statement indicating that Tom DePas, Cy Van Laanen and Ken Jacobs had successfully completed training on Board of Review procedures at the February 8, 2008 Wisconsin Town's Association Spring Meeting. Proper documentation had been filed with the Wisconsin Department of Revenue on May 11, 2009.

**MOTION MIKE VAN LANEN/TOM DEPAS** to accept and approve the Board of Review Member Training Affidavit. Vote Aye-5, No-0. Carried.

**6. Approval of Assessor Affidavit**

Assessor Robert Taicher reviewed and read the Assessor's Affidavit indicating that the assessment role had been completed following proper procedures.

**MOTION TOM DEPAS/JEFF ZLATOHLAVEK** to accept and file the Assessor's Affidavit. Vote: Aye-5, No-0. Carried.

**7. Review of Clerk's Affidavit.**

Clerk's affidavit indicated that the 2009 assessment role had been compared to the 2008 role. All parcels of property with and without improvements have been accounted for. No action needed to be taken.

**8. Appearances.**

**MOTION MIKE VAN LANEN/KEN JACOBS** to recess until an objector appears. Vote Aye-5, No-0. Carried.

**MOTION TOM DEPAS/CY VAN LAANEN** to reconvene into open session. Vote Aye-5, No-0. Carried.

Assessor Bob Taicher stated the new 2009 assessed values: \$319,601,100 Real Estate, and \$1,814,950 for Personal Property. We are still waiting on the State for Manufacturing values.
