

**TOWN OF SCOTT, BOWN COUNTY, WISCONSIN  
MINUTES OF 2010 BOARD OF REVIEW - MAY 18 2010, 4:00 P.M.**

- 1. Call To Order:** The 2010 Town of Scott, Brown County, Wisconsin 2010 Board of Review was called to order at 4:00 P.M. on Tuesday May 18, 2010 in the Town Hall. Present were Chairman Mike Van Lanen, Supervisor Cyril Van Laanen, Supervisor Kenneth Jacobs, Supervisor Jeffrey Zlatohlavek, Clerk/Treasurer John Roth, and Assessor Robert Taicher. Absent: Supervisor Colleen Harris.
- 2. Appointment of Chairman of 2010 Board of Review**  
**MOTION KEN JACOBS/CY VAN LAANEN** to nominate Mike Van Lanen as Chairman of the 2010 Board of Review. There were no other nominations. Vote: Aye-4, No-0. Carried.
- 3. Appointment of Vice-Chairman of 2010 Board of Review**  
**MOTION JEFF ZLATOHLAVEK/MIKE VAN LANEN** to nominate Cy Van Laanen as Vice-Chairman of the 2010 Board of Review. There were no other nominations. Vote: Aye-4, No-0. Carried.
- 4. Approval of Affidavit of Posting:** Clerk Roth presented an affidavit that stated that the notice of the 2010 Board of Review had been published in the Green Bay Press Gazette on May 5, 2010 and posted on five bulletin boards in the Town of Scott on May 3, 2010.  
**MOTION KEN JACOBS/CY VAN LAANEN** to approve/file the affidavit of posting. Vote Aye-4, No-0. Carried.
- 5. Certification of Board Members Training.** Roth presented a statement indicating that Ken Jacobs, Cy Van Laanen and Jeff Zlatholavek have successfully completed training on Board of Review procedures at the February 20, 2010 Wisconsin Town's Association District Meeting. Proper documentation had been filed with the Wisconsin Department of Revenue on May 17, 2010.  
**MOTION MIKE VAN LANEN/KEN JACOBS** to accept and approve the Board of Review Member Training Affidavit. Vote Aye-4, No-0. Carried.
- 6. Approval of Assessor Affidavit:** Assessor Robert Taicher reviewed and read the Assessor's Affidavit indicating that the assessment role had been completed following proper procedures.  
**MOTION MIKE VAN LANEN/JEFF ZLATOHLAVEK** to accept and file the Assessor's Affidavit. Vote: Aye-4, No-0. Carried.
- 7. Review of Clerk's Affidavit:** Clerk's affidavit indicated that the 2010 assessment role had been compared to the 2009 role. All parcels of property with and without improvements have been accounted for, as observed.  
**MOTION KEN JACOBS/JEFF ZLATOHLAVEK** to accept and file the Clerk's Affidavit. Vote: Aye-4, No-0. Carried.
