

**TOWN OF SCOTT, BOWN COUNTY, WISCONSIN  
MINUTES OF 2011 BOARD OF REVIEW - MAY 17, 2011, 4:00 P.M.**

- 1. Call To Order:** The 2011 Town of Scott, Brown County, Wisconsin 2011 Board of Review was called to order at 4:00 P.M. on Tuesday May 17, 2011 in the Town Hall. Present were Chairman Mike Van Lanen, Supervisor Cyril Van Laanen, Supervisor Kenneth Jacobs, Supervisor Jeffrey Zlatohlavek, Supervisor Colleen Harris, Clerk/Treasurer John Roth, and Assessor Robert Taicher.
- 2. Appointment of Chairman of 2011 Board of Review**  
**MOTION KEN JACOBS/JEFF ZLATOHLAVEK** to nominate Mike Van Lanen as Chairman of the 2011 Board of Review. There were no other nominations. Vote: Aye-5, No-0. Carried.
- 3. Appointment of Vice-Chairman of 2011 Board of Review**  
**MOTION JEFF ZLATOHLAVEK/MIKE VAN LANEN** to nominate Ken Jacobs as Vice-Chairman of the 2011 Board of Review. There were no other nominations. Vote: Aye-5, No-0. Carried.
- 4. Approval of Affidavit of Posting:** Clerk Roth presented an affidavit that stated that the notice of the 2011 Board of Review had been published in the Green Bay Press Gazette on April 18, 2011 and posted on five bulletin boards in the Town of Scott on April 18, 2011.  
**MOTION KEN JACOBS/CY VAN LAANEN** to approve/file the affidavit of posting. Vote Aye-5, No-0. Carried.
- 5. Certification of Board Members Training.** Roth presented a statement indicating that Ken Jacobs, Cy Van Laanen and Jeff Zlatholavek have successfully completed training on Board of Review procedures at the February 20, 2010 Wisconsin Town's Association District Meeting. Clerk/Treasurer Roth attended and successfully completed training on Board of Review procedures on April 29, 2011 at the Town of Grand Chute. Proper documentation had been filed with the Wisconsin Department of Revenue on May 13, 2011.  
**MOTION KEN JACOBS/CY VAN LAANEN** to accept and approve the Board of Review Member Training Affidavit. Vote Aye-5, No-0. Carried.
- 6. Approval of Assessor Affidavit:** Assessor Robert Taicher reviewed and read the Assessor's Affidavit indicating that the assessment role had been completed following proper procedures.  
**MOTION KEN JACOBS/CY VAN LAANEN** to accept and file the Assessor's Affidavit. Vote: Aye-5, No-0. Carried.

**MOTION JEFF ZLATOHLAVEK/KEN JACOBS** to recess until an objector appears. Vote Aye-5, No-0. Carried.  
**MOTION KEN JACOBS/CY VAN LAANEN** to reconvene into open session. Vote Aye-5, No-0. Carried.

- 9. 2011 Real Estate Values and 2011 Personal Property Values:** Assessor Bob Taicher stated the new 2011 assessed values (without Managed Forest and without Manufacturing Assessments): \$324,207,000 Real Estate, and \$2,116,300 for Personal Property, for a total of \$326,323,300. We are still waiting on the State for Manufacturing values.  
**MOTION MIKE VAN LANEN/CY VAN LAANEN** to enter into the records the 2011 assessed values as follows: \$324,207,000, Real Estate, and \$2,116,300 for Personal Property, for a total of \$326,323,300 (no Manufacturing values). Vote Aye-5, No-0.
